SUBJECT : **PNG SANCTIONS TRAINING PROGRAM, 27th – 31st JULY 2026, LEVEL 1, MELANESIAN HAUS, DEPARTMENT OF PRIME MINISTER & NEC.**

The Sanctions Secretariat-Department of Prime Minister and National Executive Council with assistance from the Asian Development Bank (ADB) will be conducting Training Sessions on Targeted Financial Sanctions for reporting entities and statutory bodies at the **Melanesian Haus, Level 1** from the **27th to 31st July 2026**.

As such, relevant Institutions are to nominate one to two officers to attend the Targeted Financial Sanctions Training. Financial Institutions (FI's) are scheduled for the first two days, followed by Designated Non-Financial Business Professions (DNFBP's) and Government Entities or members of the National Coordination Committee (NCC) on Anti-Money Laundering, Counter-Terrorist Financing and Counter-Proliferation Financing (AML/CTF/PF).
